2. Information We Collect

2.1 Personal Information

- Account Details: Phone number, email address, or username for account creation and authentication.
- **Profile Information:** Optional display name, profile picture, and status visible to other users.

2.2 Communication Data

- **Messages & Media:** Wibeit does not read or permanently store message content. Temporary metadata (timestamps, sender/receiver IDs) may be retained only for message delivery.
- Call Data: Includes technical details such as call time and duration to establish connections. Wibeit does not record or store call content.

2.3 Device & Usage Information

- **Device Info:** Model, operating system version, and other device identifiers to maintain functionality.
- **Identifiers:** Wibeit and its partners may collect identifiers such as Android ID, Advertising ID, or App Installation ID for analytics, fraud prevention, and attribution purposes.
- **Usage Data:** Anonymous crash logs, performance statistics, and engagement data to improve reliability.

3. How We Use Your Information

- Service Delivery: Enable chat, calls, account setup, and core features.
- Authentication & Security: Verify accounts, manage sessions, and protect user data.
- **Performance & Improvement:** Diagnose errors, analyze trends, and enhance functionality.
- Customer Support: Respond to user inquiries and troubleshooting requests.
- Notifications: Send important updates, feature announcements, or security alerts.
